Acts of ragging may include:

- Verbal abuse including insults, teasing, or offensive remarks
- Forcing a student to perform acts that may cause embarrassment or humiliation
- Any act that disrupts or interferes with the academic activities of a student
- Exploiting the services of a student for personal tasks
- Any form of intimidation, threat, or harassment

Objectives:

- To create awareness among students about the serious consequences of ragging.
- To ensure a safe and secure environment for all students, particularly new entrants.
- To prevent the occurrence of ragging in any form within the campus and hostels.
- To take prompt and appropriate action against individuals found involved in ragging.
- To promote discipline, mutual respect, and a positive campus culture.

Functions of the Anti-Ragging Committee:

- To monitor and review the implementation of anti-ragging measures within the institution.
- To examine complaints related to ragging and recommend appropriate disciplinary action.
- To ensure that preventive and awareness measures against ragging are effectively implemented.
- To coordinate with the Anti-Ragging Squad for monitoring activities on the campus.

Functions of the Anti-Ragging Squad:

- To maintain strict vigilance in vulnerable areas of the campus such as hostels, corridors, canteens, playgrounds, and other common areas.
- To conduct regular inspections and surprise checks to prevent ragging.
- To immediately intervene and report any incident of ragging to the Anti-Ragging Committee.
- To ensure that students adhere to the anti-ragging regulations of the institution.

Complaint Mechanism:

Any student who is subjected to ragging or has knowledge of an incident of ragging may report the matter to the Anti-Ragging Committee or Anti-Ragging Squad immediately. Complaints may be submitted in writing to the committee or communicated to any member of the Anti-Ragging Squad.

All complaints will be treated with confidentiality and investigated promptly. Strict disciplinary action will be taken against individuals found guilty of ragging as per institutional rules and applicable regulations.

Students are encouraged to cooperate with the Anti-Ragging Committee and Anti-Ragging Squad in maintaining a respectful, safe, and ragging-free campus environment.
